As of December 2020

INCE's Chip Cards allow a smooth change of the supported mobile transmission standards (Bearer) 2G, 3G, 4G, LTE-M and NB-IoT. Each card transmits and receives on all supported bearers, provided that the wireless technologies are locally available and the mobile communication module used also supports the relevant wireless technologies.

INCE's M2M/IoT mobile communications services currently support the following mobile transmission standards in the covered footprint (as of December 2020):
